(1) Relevant covenants include the Soft Commodities Compact (SCC), Equator Principles (EP), UN Principles for Responsible Investment (PRI) and the UN Global Compact, among others.

A score of 2 requires endorsement of at least two of the following covenants, unless not relevant: EP, SCC, or PRI.

(2) Natural forests encompass primary forests as well as naturally regenerated secondary forests. (FAO)

(3) Primary forests are naturally regenerated forests of native species, where there are no clearly visible indications of human activities and the ecological processes are not significantly disturbed. (FAO)
